4.1. Harborough District Council Website

The clerk wrote to Harborough District Council to state that Parish Council's Councillor vacancies had been omitted from their website. No response was received.

5.1. Harborough District Council Local Plan Consultation

Consultation on the Issues and Options/Regulation 18 is expected to be undertaken during January to February 2024. The Issues and Options consultation is an important first public stage in preparing the new local plan. It seeks feedback on significant issues, which will inform future stages of preparation of the local plan. **AGENDA** item for the next meeting.

5.2. Fielding Palmer Hospital Consultation

The NHS in Leicester, Leicestershire and Rutland (LLR) is inviting people to have their say on proposals to improve healthcare services in Lutterworth. The public consultation responds to the changing needs of people in Lutterworth by significantly expanding the number of health services available in Feilding Palmer Hospital on Gilmorton Road, increasing the number of appointments to approximately 17,000 every year. The consultation runs until 14 January 2024.

5.3. Gartree Prison

The Government has ignored the advice of its own planning inspector and ruled in favour of a huge new prison next to the existing HMP Gartree. The controversial Government bid to create the 1,700 place prison was unanimously rejected by Harborough District Council's planning committee in April last year.

Approved & Signed:

The Secretary of State for Levelling Up, Housing and Communities has ruled the prison can be built in Harborough's countryside after the Ministry of Justice appealed against the refusal. The decision comes despite the planning inspector overseeing the appeal recommending Harborough District Council's original rejection be upheld.
